## **Tantrums, Meltdowns, and Shutdowns, Oh My!**

#### **COURSE OVERVIEW**

Meltdowns and shutdowns are common responses to sensory and emotional overload in the central nervous system of autistic individuals. Meltdowns and shutdowns are neurological responses, and as a result, the autistic individual temporarily loses control of their behavior. Often meltdowns and shutdowns are viewed as an autistic person having a temper tantrum, despite differences in root causes. Temper tantrums are developmentally appropriate, goal-driven behavioral responses and/or emotional outbursts that occur in response to unmet needs. Therefore, an understanding of the causes and characteristics of meltdowns and shutdowns is important to supporting autistic individuals.

Through PowerPoint lectures, videos, and lived experience examples from the presenter, this course will briefly define temper tantrums and the goal of temper tantrums to support an increased understanding of how a temper tantrum differs from a meltdown and/or shutdown. This course will explore the characteristics of meltdowns and shutdowns. Participants will leave with an understanding of the core differences between temper tantrums, meltdowns, and shutdowns, and ways to support autistics experiencing a meltdown or shutdown.

#### **LEARNER OBJECTIVES**

- Participants will be able to identify the differences between a temper tantrum, meltdown, and shutdown.
- Participants will be able to identify 10-15 triggers for meltdowns and shutdowns.
- Participants will be able to identify 3-5 ways to support an autistic person during a meltdown or shutdown.

Kelsie is an integrative and prescriptive play therapist drawing from theories and modalities such as Cognitive Behavioral Play Therapy, Child-Centered Play Therapy, Experiential Play Therapy, Theraplay, Adlerian Play Therapy, Attachment theory, Sand tray, Mindfulness, Art, and DIR Floortime. Kelsie has given national and international presentations on working with neurodivergent populations using play therapy.
